2017 ANNUAL GENERAL MEETING

I am writing to give you details of the resolutions to be proposed at this year's Annual General Meeting to be held at 2.30 p.m. (UK time) on Thursday, 21 September 2017 at the Company's offices at Brettenham House, 19 Lancaster Place, London, WC2E 7EN England. These resolutions are set out in the notice of Annual General Meeting on pages 4 and 5 of this document.

Shareholders should read the contents of this document in conjunction with the audited financial statements of the Company for the financial year ended 31 March 2017, together with the reports of the Directors and auditors thereon (all together, the "2017 Financial Statements") enclosed with this document.

ANNUAL GENERAL MEETING

The resolutions set out below will be proposed at this year's Annual General Meeting. Resolutions 1 to 7 are to be proposed as ordinary resolutions. This means that for each of those resolutions to be passed, more than half of the votes cast must be in favour of the resolution. Resolutions 8 and 9 are proposed as special resolutions. This means that for each of those resolutions to be passed, at least three-quarters of the votes cast must be in favour of the resolution.

Resolutions nos. 1 - 7

Resolutions nos. 1 - 7 to be proposed at the Annual General Meeting will each be proposed as an ordinary resolution as follows:-

- the receipt and adoption of the audited financial statements of the Company for the financial year ended 31 March 2017 (resolution no. 1);
- (ii) the approval of the Directors' Remuneration Report (excluding the Remuneration Policy) for the financial year ended 31 March 2017 (resolution no. 2);
- (iii) the re-election of Montague John ('Nick') Meyer and Johannes Catharina Hermanus Leonardus ('Hans') Pauli, who retire by rotation as Directors under article 88 of the Company's current articles of association and, being eligible, offer themselves for re-election each as a Director at the Annual General Meeting (resolutions no. 3 4);
- (v) the re-appointment of PricewaterhouseCoopers LLP as auditors of the Company (resolution no. 5);
- (vi) the authorisation of the Directors to determine the auditors' remuneration (resolution no. 6); and
- (vii) the renewal of authority for Directors to allot shares generally (resolution no. 7).

Directors' Remuneration Report

As with last year, this year's Remuneration Report is prepared under the new UK regime for the reporting of executive pay. Although we are quoted on AIM in the UK, our cross-listing on NYSE Euronext in the Netherlands and our UK incorporated status means that we come within the definition of a "quoted company" under the UK Companies 2006 (the "Act").

Accordingly, and exceptionally amongst AIM companies, we are therefore legally required to comply with the regime for the reporting and approval of directors' remuneration by UK quoted companies, including:

- a binding vote on the directors' remuneration policy not less than once every three years, which has applied to UK companies fully listed on the UK stock exchange from October 2013; and
- 2. an advisory (non-binding) vote on the remainder of the Remuneration Report, which includes the implementation of our remuneration policy for the year ended 31 March 2017.

The new reporting regime has not altered our core approach to director remuneration. We remain committed to pay at appropriate, but not excessive, levels and to reflect market practice amongst AIM companies.

As with many other AIM companies, our remuneration policy is more dynamic than would be typical on the Official List with long-term incentive awards not necessarily granted on an annual basis and the basis for determining bonus levels being more judgmental although the Company will increasingly look to formalise KPIs for bonuses as the Company matures.

Re-election of Directors

Nick Meyer acts as Non-Executive Director of the Company pursuant to a letter of appointment with the Company dated 17 May 2011 (as amended on 10 June 2014, 10 February 2015 and 14 June 2017).

Hans Pauli acts as Executive Director, Corporate Development pursuant to a service contract with the Company dated 1 March 2010.

The performances of Messrs Meyer and Pauli were evaluated between January and March 2017, alongside all other Directors of the Company, by an independent corporate governance consultant. The results of the evaluation determined that each Director continues to be effective and continues to demonstrate commitment to their respective roles.

Further information about these Directors may be found in my Chairman's Statement at pages 8 to 9 of the enclosed 2017 Annual Report and Financial Statements.

Renewal of Authority for Directors to allot shares generally

Resolution no. 7 will be proposed as an ordinary resolution to give the Directors a general authority, in accordance with section 551 of the Act, to allot shares. Paragraph (A) of this resolution would give the Directors the authority to allot ordinary shares or grant rights to subscribe for or convert any securities into ordinary shares up to an aggregate nominal amount equal to €1,851,088 (representing 37,021,764 ordinary shares of €0.05 each). This amount represents approximately one-third of the issued ordinary share capital of the Company as at the date of this document.

In line with guidance issued by the Association of British Insurers ("ABI"), paragraph (B) of this resolution would give the Directors authority to allot ordinary shares or grant rights to subscribe for or convert any securities into ordinary shares in connection with a rights issue in favour of ordinary shareholders up to an aggregate nominal amount equal to €3,702,176 (representing 74,043,527 ordinary shares of €0.05 each), as reduced by the nominal amount of any shares issued under paragraph (A) of this resolution. This amount (before any reduction) represents approximately two thirds of the issued ordinary share capital of the Company as at the date of this document.

The authorities sought under paragraphs (A) and (B) of this resolution will expire at the conclusion of next year's Annual General Meeting or 15 months after the passing of the resolution (whichever is earlier).

This authority replaces the authority to allot shares generally as given to the Directors at last year's Annual General Meeting.

Resolutions nos. 8 and 9

Resolutions nos. 8 and 9 are to be proposed as special resolutions - as follows:-

Resolution no. 8 - Renewal of Authority for Directors to allot shares for cash disapplying statutory pre-emption rights Resolution no. 8 will be proposed as a special resolution to authorise the Directors to allot ordinary shares for cash (otherwise than pro rata to existing shareholdings) in connection with a rights issue, open offer or any other pre-emptive offer in favour of the holders of ordinary shares which is made not strictly in accordance with section 561 of the Act or otherwise up to a maximum aggregate nominal value of €555,326 (representing approximately 10% of the Company's issued ordinary share capital at the date prior to the printing of this document). This authority replaces the resolution passed at last year's Annual General Meeting and will expire at the conclusion of next year's Annual General Meeting or 15 months after the passing of the resolution (whichever is the earlier).
