Dear Shareholder,

2019 ANNUAL GENERAL MEETING

I am writing to give you details of the resolutions to be proposed at this year's Annual General Meeting to be held at 11.45 a.m. (UK time) on Monday, 30 September 2019 at the Company's offices at Brettenham House, 19 Lancaster Place, London, WC2E 7EN England. These resolutions are set out in the notice of Annual General Meeting on pages 4 and 5 of this document.

Shareholders should read the contents of this document in conjunction with the audited financial statements of the Company for the financial year ended 31 March 2019, together with the reports of the Directors and auditors thereon (all together, the '**2019 Financial Statements**') enclosed with this document.

ANNUAL GENERAL MEETING

The resolutions set out below will be proposed at this year's Annual General Meeting. Resolutions 1 to 7 are to be proposed as ordinary resolutions. This means that for each of those resolutions to be passed, more than half of the votes cast must be in favour of the resolution. Resolutions 8 and 9 are proposed as special resolutions. This means that for each of those resolutions to be passed, at least three-quarters of the votes cast must be in favour of the resolution.

Resolutions nos. 1 – 7

Resolutions nos. 1 – 7 to be proposed at the Annual General Meeting will each be proposed as an ordinary resolution as follows:-

- (i) the receipt and adoption of the audited financial statements of the Company for the financial year ended 31 March 2019 (*resolution no. 1*);
- (ii) the approval of the Directors' Remuneration Report (excluding the Remuneration Policy) for the financial year ended 31 March 2019 (*resolution no. 2*);
- (iii) the re-election of myself, Patrick Shanley, and William Bickerton Rudge who retire by rotation as Directors under article 88 of the Company's current articles of association and, being eligible, offer themselves for re-election each as a Director at the Annual General Meeting (*resolutions no. 3 and 4*);
- (iv) the re-appointment of PricewaterhouseCoopers LLP as auditors of the Company (*resolution no. 5*);
- (v) the authorisation of the Directors to determine the auditors' remuneration (*resolution no. 6*); and
- (vi) the renewal of authority for Directors to allot shares generally (*resolution no. 7*).

Directors' Remuneration Report

As with previous years, this year's Remuneration Report is prepared under the UK regime for the reporting of executive pay which has applied to UK companies fully listed on the UK stock exchange from October 2013. Although we are quoted on AIM in the UK, our cross-listing on NYSE Euronext in the Netherlands and our UK incorporated status means that we come within the definition of a 'quoted company' under the UK Companies Act 2006 (the '**Act**').

Accordingly, and exceptionally amongst AIM companies, we are therefore legally required to comply with the regime for the reporting and approval of directors' remuneration by UK quoted companies, including:

1. a binding vote on the directors' remuneration policy not less than once every three years; and
2. an advisory (non-binding) vote on the remainder of the Remuneration Report, which includes the implementation of our current remuneration policy for the year ended 31 March 2019.

Our remuneration policy was last approved by shareholders at the Annual General Meeting in September 2018 following a review of our remuneration framework and engagement with major investors. Limited changes were made to our Remuneration Policy last year and one year on the Board continues to believe that the Remuneration Policy implemented is appropriate and the remuneration structure and mechanisms align shareholder and Executive Director interests as we continue in a period of rapid growth.

We remain committed to pay at appropriate, but not excessive, levels and to reflect market practice amongst AIM companies.

Re-election of Directors

I, Patrick Shanley, act as a Non-Executive Director and Chairman of the Company pursuant to a letter of appointment with the Company dated 18 November 2010 (as subsequently amended).

I will have served on the Board of Directors for nine years in November of this year. It is considered best corporate governance practice to step down from the Board after 9 years unless there are special circumstances. The Board fully supports the adoption of best corporate governance practice and whilst not mandatory under the QCA Corporate Governance Code, I intend to step down as your Chairman in the near term. However, to allow for continuity, stability and oversight as we look to bed-in a new CEO, the Board and I believe it to be in the best interests of shareholders for me to step down when we feel the new CEO has had a suitable period within the business. It is our expectation that this will be before the end of calendar year 2020. I therefore offer myself for re-election.

William Rudge acts as Finance Director of the Company pursuant to a service contract with the Company dated 1 October 2012 and alongside me, also offers himself up for re-election at the AGM.

Further information about William and myself may be found at pages 40 to 41 of the enclosed 2019 Annual Report and Financial Statements.

Renewal of Authority for Directors to allot shares generally

Resolution no. 7 will be proposed as an ordinary resolution to give the Directors a general authority, in accordance with section 551 of the Act, to allot shares. Paragraph (A) of this resolution would give the Directors the authority to allot ordinary shares or grant rights to subscribe for or convert any securities into ordinary shares up to an aggregate nominal amount equal to €1,966,472 (representing 39,329,435 ordinary shares of €0.05 each). This amount represents approximately one-third of the issued ordinary share capital of the Company as at the date of this document.

In line with guidance issued by the Association of British Insurers ('ABI'), paragraph (B) of this resolution would give the Directors authority to allot ordinary shares or grant rights to subscribe for or convert any securities into ordinary shares in connection with a rights issue in favour of ordinary shareholders up to an aggregate nominal amount equal to €3,932,944 (representing 78,658,870 ordinary shares of €0.05 each), as reduced by the nominal amount of any shares issued under paragraph (A) of this resolution. This amount (before any reduction) represents approximately two thirds of the issued ordinary share capital of the Company as at the date of this document.

The authorities sought under paragraphs (A) and (B) of this resolution will expire at the conclusion of next year's Annual General Meeting or 15 months after the passing of the resolution (whichever is earlier).

This authority replaces the authority to allot shares generally as given to the Directors at last year's Annual General Meeting.

Resolutions nos. 8 and 9

Resolutions nos. 8 and 9 are to be proposed as special resolutions – as follows:-

Resolution no. 8 – Renewal of Authority for Directors to allot shares for cash disapplying statutory pre-emption rights

Resolution no. 8 will be proposed as a special resolution to authorise the Directors to allot ordinary shares for cash (otherwise than *pro rata* to existing shareholdings) in connection with a rights issue, open offer or any other pre-emptive offer in favour of the holders of ordinary shares which is made not strictly in accordance with section 561 of the Companies Act 2006 or otherwise up to a maximum aggregate nominal value of €589,942 (representing approximately 10% of the Company's issued ordinary share capital at the date prior to the printing of this document). This authority replaces the resolution passed at last year's Annual General Meeting and will expire at the conclusion of next year's Annual General Meeting or 15 months after the passing of the resolution (whichever is the earlier). The resolution will enable the Directors, at their discretion, to allot a limited number of equity securities for cash and also provide the Directors with greater flexibility to take advantage of business opportunities as they arise.

Resolution no. 9 – Authority to purchase own ordinary shares

It is proposed by a special resolution (no. 9) that the Company be authorised to purchase up to 11,798,831 of its own ordinary shares in the market, representing approximately 10% of the current issued ordinary share capital of the Company, at a price at not less than the nominal value of the ordinary shares and not more than the highest of (i) 5% above the average of the middle market quotations of the Company's ordinary shares as derived from the London Stock Exchange Daily Official List for the 5 business days before the purchase is made and (ii) the higher of the price of the last independent trade and the highest current independent bid on the trading venues where the purchase is carried out. The authority would be given for the period ending on the date of next year's Annual General Meeting or 15 months after the passing of the resolution (whichever is the earlier) and it is anticipated that a resolution for the renewal of such authority will be proposed at each future Annual General Meeting.

Whilst the Directors have no present intention of making such purchases, it is considered prudent to have this authority so as to be able to act at short notice if circumstances change. The authority would however only be exercised if the Directors believe that to do so would result in an increase in earnings per share and would be in the best interests of shareholders generally.

Options over an aggregate of 4,935,421 ordinary shares in the Company under the Company's existing Share Option Schemes and Long-Term Incentive Plan were outstanding as at the date of this document representing approximately 4.18% of the Company's issued share capital at that date and which would represent 4.65% of the Company's issued share capital if the proposed authority being sought at the 2019 Annual General Meeting to buy back 11,798,831 ordinary shares was exercised in full.

The resolution will also permit the Company to purchase its own shares to hold as 'treasury shares'. As at the date of this document the Company did not hold any of its ordinary shares as treasury shares.

The Directors would consider holding as treasury shares any shares which the Company purchases pursuant to the authority proposed to be granted by resolution no. 9.

Action to be taken in respect of Annual General Meeting

Shareholders will find enclosed with this document a form of proxy for use at the Annual General Meeting. Whether or not you intend to be present at the Annual General Meeting, you are requested to complete, sign, date and return the form of proxy so as to reach the Company's Registrars, SLC Registrars, by post at Elder House St Georges Business Park, Brooklands Road, Weybridge, Surrey, KT13 0TS or by sending a completed, signed and dated scanned version of the proxy form by email to accsysproxy@davidvenus.com as soon as possible and in any event not later than 48 hours before the time appointed for the Annual General Meeting (excluding days which are not working days), being 11.45 a.m. (UK time) on Thursday, 26 September 2019.

Completion and return of a form of proxy will not however prevent you from attending at the Annual General Meeting and voting in person if you should wish to do so.

RECOMMENDATION

Your Directors are unanimously in favour of resolutions nos. 1 – 9 (inclusive) to be proposed at this year's Annual General Meeting, which they consider to be in the best interests of the shareholders of the Company as a whole. Accordingly, your Directors unanimously recommend shareholders to vote in favour of those resolutions at the Annual General Meeting, as they intend to do in respect of any of their own beneficial holdings of ordinary shares.

1. Any member of the Company entitled to attend and vote at this Annual General Meeting may appoint one or more proxies to exercise all or any of his or her rights to attend, speak and vote at the meeting. Where more than one proxy is appointed, each proxy must be appointed to exercise the rights attached to a different share or shares held by that shareholder. A proxy need not be a member of the Company.
2.
